## The Jamestown Foundation Reprint/Redistribution Request Guidelines & Permissions Application

The Jamestown Foundation is a public non-profit organization under sections 501(c)(3) and 509(a)(1)(2) of the Internal Revenue Code. All publications of the Jamestown Foundation, including *North Caucasus Weekly*, *China Brief*, *Eurasia Daily Monitor*, *Terrorism Focus*, and *Terrorism Monitor*, are distributed free of charge over the internet as a public service to our subscribers. Accordingly, unauthorized reproduction, redistribution, or translation of Jamestown material is strictly prohibited by U.S. copyright law.

To request permission to reproduce or redistribute Jamestown material, the requesting organization or individual must fill out the attached permissions request chart and sign below. These two forms should be sent via post or fax to:

Each permission request will be considered on a case by case basis by the President of the Foundation. Non-profit, educational, and government institutions will not be charged for reproduction, redistribution, or translation rights for Jamestown material. For-profit organizations and businesses will be required to pay a fee for granted reproduction, redistribution, and translation rights commensurate with the product's value to the given organization.

All reproductions of Jamestown material, either internet or paper, must meet the following requirements for consideration.

- All material must be accurately reproduced, including title, paragraph headers, and author
- All articles must be properly cited, with full attribution to The Jamestown Foundation, the corresponding publication, and author
- Each citation must be located at the top or beginning of each reproduction in a readable and accessible manner
- All internet reproductions of Jamestown material must have a working link to the original document from our website archives [www.jamestown.org](http://www.jamestown.org)

Failure to meet the stated requirements will lead to a termination of the granted reproduction, redistribution, or translation permission. The President of the Foundation reserves the right at any time to deny a permission request or terminate any pre-existing permission agreement.
